RELEASE

RELEASE, made this 67H day of APRIL , 2005, by EQUITRANS, L.P., at 100 Allegheny Center Mall, Pittsburgh, PA 15212, hereinafter called "First Party," and CINCAST CORPORATION, of 5631 Steubenville Pike, Pittsburgh, PA 15244, hereinafter called "Second Party".

The said First Party hereto, for and in consideration of the sum of ONE AND NO/100 DOLLAR (\$1.00), this day to it in hand paid by the Second Party, discharge and forever quit claim unto the Second Party, all of its rights and privileges in and to a <u>portion</u> of the following Pipeline Right-of-Way Grant situate in Kennedy Township, Allegheny County, Pennsylvania on Block/Lot Number 154-S-153.

1. H. C. A. Hofacker to Socony-Vacuum Oil Company, Inc., dated October 9, 1946. Recorded in Deed Book Volume 2918, Page 473.

Section of pipeline to be released is delineated on Exhibit "C" which is attached hereto and made a part hereof. Said portion of Pipeline Right of Way being described as follows:

BEGINNING at the southeasterly corner of the said gas line right-of-way hereinafter described, said point being distant North 20° 54' 20" East, 198.84 feet from the northeasterly corner of Lot 2 in the aforesaid Cincast Corporation Plan of Lots and being common with the westerly right-of-way line of McKees Rocks and Steubenville Road; thence from said point of beginning and through the aforesaid lands of Cincast Corporation, the following six courses: North 89° 56' 00" West, 260.92 feet; thence South 69° 31' 03" West, 601.85 feet; thence North 52° 13' 16" East, 48.14 feet; thence North 56° 41' 05" East, 160.68 feet; thence North 69° 31' 03" East, 408.29 feet; thence South 89° 56' 00" East, 289.01 feet to a point on the aforesaid westerly right-of-way line of McKees Rocks and Steubenville Road; thence along said westerly right-of-way line South 20° 54' 20" West, 53.50 feet to the point of beginning. Containing an area of 39,303 square feet or 0.902 acres.




