## **PIPELINE RIGHT-OF-WAY**

THIS AGREEMENT, made the 27<sup>th</sup> day of October, 2009, by Kathy Westbeld a/k/a/ Kathy Kucsmas & Bryan Kucsmas (h&w), as Grantor(s), and

Huntley & Huntley, Inc. hereinafter referred to as Grantee.

WITNESSETH, that in and for consideration of Ten Dollars (\$10.00) paid to Grantors, the receipt of which is acknowledged, Grantors do hereby grant unto Grantee, its successors and assigns, with special warranty, the right of way to lay, maintain, operate, replace, and remove a pipeline with fittings and appliances for the transportation of water, oil, gas, and other products from this or other lands, upon and over those certain lands situate in the Township of <a href="Elizabeth">Elizabeth</a>, <a href="Allegheny">Allegheny</a> County, Pennsylvania, bounded substantially by lands now or formerly owned as follows:

Tax ID Parcel Number 1267-D-90, being 53.0309, acres more or less,

On the North by the Lands of Butlers Golf Coarse; Small Lots

On the East by the Lands of Small Lots

On the South by the Lands of J. Pribanic

On the West by the Lands of A. Ball; Small Lot

together with the right of ingress and egress to and from said right of way; together also with the right and privilege of using said lands for the purpose of transporting pipe, material, machinery, and equipment to and from other lands in and about the construction, maintenance, operation, replacement, and removal of the pipeline to be constructed hereunder; together also with the right at any time to replace said pipeline; and together also with the right to install, maintain, and replace on said pipeline devices for cathodic protection, test stations, and bonding cables. Grantor and Grantee shall mutually approve the location of all pipeline(s), same of which will not be unilaterally withheld. At such time as this Pipeline Right-of-Way is utilized, Grantee shall pay to Grantor as further consideration, One Dollar (\$1.00) per foot of Right-of-Way actually installed/laid.

The Grantors, their heirs and assigns, shall use and enjoy said lands except for the purposes herein granted to Grantee, which hereby agrees to pay for any damages to crops and fences arising from the installation, maintenance, operation, replacement, and/or removal of said pipeline. The location of all pipeline(s) shall be by mutual consent same of which shall not be unilaterally denied.
