PARTIAL SURRENDER OF PIPELINE RIGHT-OF-WAY

WHEREAS, by instrument dated January 14, 1960, Mary McCune, single, granted to the Peoples Natural Gas Company, its successors and assigns, a Right of Way Grant to lay, maintain, operate, change and remove pipelines with necessary drips, gate valves, and appliances, including cathodic protection equipment, for the transportation and regulation of water, oil or gas, over and through her lands located in Findlay Township, Allegheny County, State of Pennsylvania, which instrument is recorded in the Recorder of Deeds Office of said County, in Deed Book Volume 3844, Page 79; and

WHEREAS, McClaren LP, a Pennsylvania Limited Partnership, is now the owner of two tracts of property assessed as Tax Map 9910, Parcels X-82265 and X-83977 in Finlay Township, Allegheny County. It is the intent of this Partial Surrender to assist in the title curative of aforesaid mentioned property and to release only those rights of the above mentioned Pipeline Right of Way Grant that may be relevant to the property indicated on the attached Exhibit "A". All other rights of said Right of Way Grant shall remain in full force and effect.

NOW, THEREFORE, that for and in consideration of the sum of One Thousand Five Hundred Dollars (\$1,500.00), to it in hand paid, receipt of which is hereby acknowledged, the said THE PEOPLES NATURAL GAS COMPANY d/b/a DOMINION PEOPLES, intending to be legally bound hereby, release, relinquish, quitclaim and surrender for cancellation to McClaren, LP, A Pennsylvania LIMITED Partnership, its interest in the above Pipeline Right of Way Grant that may be relevant to the property indicated on the attached Exhibit "A".


